## **BRIJENDRA SHEKHAR WELFARE SCHEME**

**INTRODUCTION**: Air traffic Controllers' Guild India, the esteemed institution was established in 1964, since then this association is known for its legacy. ATC Guild has brought many laurels for Civil Aviation in India in general and for Air Traffic Controllers in particular.

Looking into the past, it was felt by CEC to start a welfare scheme for its membership as a lifetime relationship. ATC Guild India launched BSWS scheme in remembrance of our beloved veteran leader Late Shri Brijendra Shekhar effective from 1<sup>st</sup> January 2021.

Brijendra Shekhar Welfare Scheme (BSWS), is the revolutionary step for our ATC Guild India membership to provide financial assistance to the family of deceased ATC Guild member and to felicitate the ATC Guild member on superannuation day.

The BSWS corpus fund of minimum 1 crore will be created with an initial contribution of 50 lacs from Ephemeral fund of ATC GUILD(INDIA) and 50 lacs will be collected from individual subscribers of the scheme. The amount of contribution to be collected from individual members will be informed to membership after getting the final number of participants in the BSW Scheme.

One trust will be formed with two nominees from CEC and all regional Secretaries as trusty to manage the fund of BSWS.

BSWS has two welfare measures for ATC Guild members:

- 1. Benefit of 20 lacs pay out to the family member (declared nominee by member) in case of unfortunate demise of bona fide members of the BSWS.
- 2. Superannuation memorabilia of Rs.10000 to ATC Guild member.

**OBJECTIVE:** The thought behind the BSWS is to keep the connect between ATC Guild and its membership which will provide the paperless financial support to grieved family in case of unfortunate demise of ATC Guild member.

Also, it gives immense pride to honor the ATC GUILD Members on their superannuation day for their unconditional support and/or contribution to this ATC Guild.

**ELIGIBILITY:** All members of ATC Guild (India). We expect 100% participation of all ATC GUILD(INDIA) members but for members who does not want to be part of it can send their unwillingness to General Secretary, ATC Guild maximum by 31<sup>st</sup> March 2021. For eligibility the following points are to be taken care of:

- Participant shall be a member of ATC Guild (India)with all dues cleared up to the previous quarter
  - from the date of claim.
- 2. A person shall pay all latest contribution requests generated by CEC from time to time for fund recoupment to be the beneficiary of this scheme. Failing in paying the contribution for fund recoupment will result in non-subscription to BSW Scheme automatically.

**BSWS FUND RECOUPMENT:** Presently, BSWS corpus fund will be having a minimum of 1 crore which can cater up to 5 untimely demises of BSWS member. Once pays out for 3 demises i.e. payment of 60 lacs to beneficiaries, the fund will be recouped by collecting 60 lacs from membership based on the demand raised by CEC for member's contribution.

**PROCEDURE FOR CLAIM IN CASE OF DEMISE:** The claim settlement in case of demise of an bona fide members of BSWS will be through following procedure:

- 1. Branch Secretary will send the details of deceased member to CEC/ BSWS Trust along with the certification of current membership and details of contribution pay out to the Scheme.
- 2. The details of beneficiary sent by Branch secretary shall be ratified by Regional Secretary.
- 3. Regional Secretary will send the ratified details of member to BSWS trust which consists the following members
  - I. Two nominees from CEC
  - II. All Regional Secretaries
- 4. Once received, BSWS Trust will approve the release of Rs.20 lacs based on committee recommendations.

**PROCEDURE FOR PRESENTING MEMORIBILIA:** Branch Secretary shall send the list of superannuating ATC Guild members bi-annually for a period from 01<sup>st</sup> January to 30<sup>th</sup> June by 15<sup>th</sup> December of previous year and for the period from 01<sup>st</sup> July to 31<sup>st</sup> December by 15<sup>th</sup> June of the current year. Regional Secretary shall ratify the current membership of ATC Guild member concerned.

CEC will send the memorabilia to concerned Regional Secretaries for their region members. RS shall send it to concerned branches.

**CUSTODIAN OF FUND:** The authorized signatories as per ATC Guild India Constitution will be the custodian of the BSWS fund.

**DISPUTE RESOLUTION:** In case of any dispute, the decision of BSWS Trust will be final.
