The complete procedure for the joining is specified in Annexure II.


**CUSTODIAN OF FUND:** The authorized signatories as per ATC Guild India Constitution will be the custodian of the BSWS fund.

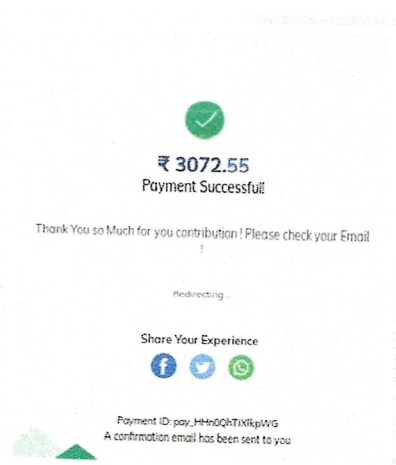
#### TERMS & CONDITIONS:
